This year's event is scheduled for **Saturday, May 29th, 2021, from 11:00am to 5:00pm** (setup starts at 8:00am on Saturday morning, please be set up by 10:45am). **This is just a tentative date; event may be cancelled at any time due to Covid-19 restrictions.** Please note, if cancelled for this reason, you will be 100% refunded.

Promotion: We will be advertising this event through our weekly newsletter, social media sites, signage, and all of our Chamber events/meetings. We are accepting applications for vendors and food trucks. To take advantage of all promotional opportunities, please be aware of application deadlines.

Location: TBD- Map will be provided prior to event.

Vendors: This event is open to all types of vendors and food trucks. Applications will be reviewed on a first come, first serve basis. You will be notified once application is accepted. Limited spaces available for informational booths. Please contact the Chamber Office with any questions or concerns. ST-124, Idaho Sales Tax Declaration will be emailed to each vendor, it is your responsibility to complete and return to the state. Booths providing food and beverage must have a Temporary Event Food Establishment License, Fire Code Inspection sticker, and all documents required per City Ordinance (4-11-3).

Please note, all food vendors will be located in a central location. **All vendors needing electricity must be self-sufficient, all SO cords to generators, trucks, or booths, must be covered and in compliance with the new Fire and State Electrical Codes.**

Cost: Chamber members- \$20, Non-Profit (Chamber member)- \$15, Non-Chamber Member (Including non-profit)- \$35.00, and Food Trucks (Non-Chamber member)- \$75.00. No refunds will be given due to personal reasons/no shows after May 7th. **(Chamber Members: to receive reduced rates, your 2021 membership dues must be up to date).**

Space: 10ft x 10ft space is provided, anything over that size will require a double charge. Food trucks need to provide dimensions for adequate space allotment and pricing. Please bring any items necessary for your areas display, tables and chairs are not provided. Please know that we will work to the best of our ability to accommodate everyone in the space as requested in the application, but we may have to adjust booth size or location accordingly. Limited spaces available, we appreciate your understanding and patience.

Deadline: May 7th, 2021 is this events deadline. All applications and payments must be remitted to the Chamber office. Space is limited, any vendor who has not paid vendor fees by the deadline will forsake their spot to the next vendor on the waiting list. Covid-19 protocols will be in place. We will highly encourage vendors to follow and enforce these measures. Those that do not wish to comply, may forfeit their space. Refunds will not be given after May 7th, 2021.

___ Food/Beverage Booth- I have my Fire and City Code Inspection complete. Temporary Event Food Establishment License Application and Vender Packet must be completed. These forms need to be completed and turned into the Elmore County Central District Health Department 30 days prior to the event.
